11. Any alterations made to this Form of Proxy should be initialled.
12. The completion and return of this Form of Proxy (or transmission of a proxy appointment or voting instruction online, electronically through CREST by post or by email or by any other procedure described in the Scheme Document) will not prevent you from attending, submitting questions and voting at the General Meeting, if you are entitled to and wish to do so.
13. In the case of joint holders of Brewin Dolphin Shares, the vote of the senior who tenders a vote, whether remotely or by proxy, will be accepted to the exclusion of the vote(s) of the other joint holder(s). For this purpose, seniority will be determined by the order in which the names stand in the register of members of Brewin Dolphin in respect of the joint holding.
14. As an alternative to appointing a proxy, any holder of Brewin Dolphin Shares which is a corporation may appoint one or more corporate representatives who may exercise on its behalf all its powers as a member, provided that if two or more corporate representatives purport to vote in respect of the same shares, if they purport to exercise the power in the same way as each other, the power is treated as exercised in that way, and in other cases the power is treated as not exercised.
15. The 'Vote Withheld' option is provided overleaf (and may be available on the CREST system) to enable you to abstain from voting. However, it should be noted that a 'Vote Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a resolution.
